

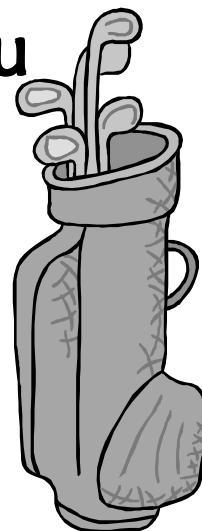

6. Turn Right on Stoneridge Drive
