Priority consideration will be given to those with an agricultural background, FFA or an intended major in an agriculture-related field. In addition, each award winner will receive a one year Student Membership in the Oregon Farm Bureau.

Students will be selected by a scholarship committee of UMCFB board members.

Successful applicants will be selected based on accomplishments and need. It is not necessary for a family member to be a member of UMCFB, nor is a high GPA a requirement. Emphasis will be placed on ability, personal goals, school and community participation and citizenship.

All applications must be printed and returned with required documents to the address below by **April 20, 2026**. Please closely follow the directions set forth by the scholarship committee on what information is to be included with the application. Please **DO NOT** add extra pages; list only the top five activities, employment opportunities, community service, leadership roles and recognition in each of the categories that were the most influential or where you were most active. We **DO NOT** accept Letters of Recommendation. Please be certain the application you are submitting is the **2026** version, as the essay topic changes every year.

All essays submitted will be subjected to a process to assure that they are of original content and **NOT** the product of Artificial General Intelligence. Any application found to be in violation will be immediately discarded.

From your perspective what are the potential consequences of Initiative Petition 28 (IP28) on Oregon’s rural communities, wildlife conservation, animal husbandry practices and how might this, as a state law, criminalize hunting, fishing, trapping, as well as farming and ranching?"
